I. ANNOTATION

This course is practical oriented to the legal regulations, related to the performance of business as an activity, independent from the particular economic sphere. According to the thematic content the particular problems concern simultaneously private law, as well as public law branches. It includes basic questions related to the legal form of performing business, statute of the European companies and offshore zones. There are also questions of the Competition law – concept of competition, types of unfair competition and protection. The problems of the financial procedure and issuing of revision acts insolvency and bankruptcy are clarified. The measures for reorganization of the enterprise are also presented. Exactly this specificity motivates the actuality and necessity of this scientific subject – the coverage in a wider content of the legal aspects and problems, which may arise during performing business.

The expected results from the course could be summarized in following parameters: understanding of the legal regulations, work with normative documents, increasing the knowledge and skills for implementation in practice.
