University of Economics – Varna : Past and present

University of Economics - Varna was established as Bulgaria's first Higher School of Commerce following the industrial and cultural boom at the turn of the 20th century and the ever growing need for business training. In 1911 Varna Chamber of Commerce and Industry management started planning the establishment of the Higher School of Commerce, whose launch was voted on 14 May 1920 at the Chamber's 25thsession. This date is considered the onset of Bulgaria's higher economic education.

Today the university is an accredited educational and research institution certified with ISO 9001:2015. In 2018, as proof of the university growing reputation, Bulgaria's National Evaluation and Accreditation Agency awarded University of Economics – Varna the top grade of 9.28 for institutional accreditation, fully acknowledging this HEI educational quality and its compliance with Bulgaria's Higher Education Act.

University of Economics – Varna supports educational and research exchange projects with international academic centres. It establishes and maintains international contacts and liaises with almost 190 universities internationally. It has been a partner HEI in a range of mobility exchange programmes, such as ERASMUS+, CEEPUS, TEMPUS, etc. Over five per cent of UE – Varna students complete work placements and internships internationally.

Over 300 international students from 52 countries are currently pursuing their degrees at UE – Varna. We are partners with 258 universities from 45 countries and we are one of the three locations (along with Valencia and Toulouse) for UK's Nottingham Business School work placements. We have over 1,800 corporate and public admin partners.

In 2011 University of Economics – Varna library was awarded the "Library of the Year" Prix by the Bulgarian Library and Information Association. Today the university library is one of country's top state-of-the-art libraries boasting over 350,000 library items and a subscription to the best professional electronic databases.


